Sir,

As per the directions of Ministry of Finance vide O.M. No.10/1/2011-PPC dated 30th November, 2011, it was made mandatory for all Ministries/ Department of the Central Government, their attached and subordinate offices to publish their tender enquiries, corrigenda thereon and details of bid awards on the Central Public Procurement (CPP) Portal using e-publishing mode. E-publishing module of CPP Portal of NIC is being utilized by Central Water Commission for publishing tender enquiries and other related documents.

In this regard, Under Secretary, MOWR, RD&GR vide letter No. 12/68/2011-Coord. dated 24.09.2014 forwarded a copy of Ministry of Finance, Department of Expenditure's O.M. No. 66(43)/PF-1112014 dated 08.09.2014 wherein it has been informed that as ascertained from NIC, very few purchasing entities are putting up details of bid award on CPP Portal and asked all the Ministries/ Departments to direct all purchasing entities under their respective control to publish details of the bid award on CPP Portal. The aforesaid OM is available in the circular section of CWC website which was uploaded on 10.10.2014.

Under Secretary, MOWR, RD&GR vide reminder letter No. 12/68/2011-Coord. dated 09.03.2015 (copy enclosed) has requested to send a compliance report in the matter.

It is, therefore, requested that all purchasing entities under your organization may be informed in this regard and ensure publishing details of the bid award also on CPP Portal. A compliance report in the matter may be furnished at the earliest for further submission of consolidated information in respect of CWC to the MOWR, RD&GR.
