2. Service tax will be released on production of proof of payment receipt/challan.
3. 2% Income tax & other taxes as applicable shall be deducted from the total amount.

4. An EMD of 2% on quoted total amount shall be enclosed in the form of DD in favour of Executive Engineer, LGD, CWC, Hyderabad payable at Hyderabad. The EMD of unsuccessful bidder will be returned back immediately after finalization of bids. The EMD of the successful bidder will be released after completion of the contract/ renewal/ extended period.
5. Security Deposit may be deducted 10% from the running bill. Any damage/penalty to the Govt. property it will be adjusted from the security deposit, if the same could not be adjusted, it will be adjusted in other monthly bills payable to the contractor from time to time during the contract period.
6. Rates shall be indicated on monthly basis. Non performance of work by the personal to the satisfaction of the CWC official in charge of works shall be rectified immediately failing which payment for the work will not be allowed. If the non satisfactory performance is noticed more than three times a month, in addition to the non payment of the work personal penalty at the rate of Rs.100/-, will be deducted on the monthly basis.
