**Terms & Conditions:**

1. The cover containing the quotations should be super scribed with **“Quotation for Semi-skilled Personals under ISD, CWC, Jagdalpur”**.
2. Service tax will be released on production of proof of payment.
3. 2% Income tax & other taxes as applicable shall be deducted from the total amount.
4. Security deposit may be deducted 10% from the running bill. Any damage/penalty to the Govt. property it will be adjusted from the security deposit (EMD), if the same could not be adjusted, it will be adjusted in other monthly bills payable to the contractor from time to time during the contract period.
5. Rates shall be indicated on monthly basis. Non performance of work by the personal to the satisfaction of the CWC official in charge of works shall be rectified immediately failing which payment for the work will not be allowed. If the non satisfactory performance is noticed more than three times a month, in addition to the non-payment of the work personal penalty at the rate of Rs.100/-, will be deducted on the monthly basis. The security deposit (EMD) of the contractor will be forfeited.
6. The offer of rates kept open valid for a period of six months from the date of opening of the quotation.
7. After satisfactory completion of the works in all respects, the bill for the month may be submitted in triplicate for payment to the undersigned.
8. The right to reject any quotation or all the quotations without assigning any reasons there off, rests with the undersigned.
9. Only those firms who are having experience in executing of the works and capable to complete the works need to quote their rates, a copy of the cliental list in this regard may be submitted along with the quotation.
10. The firm should have registered to man power assistance / labour service with central or state Govt. Also it should have registration for EPF, ESI & Registration cum Labour Commissioner. The firm should have at least one year experience in the business of providing man power assistance/labour services.
