Terms & Conditions:

1. The quotations duly signed should be properly sealed and dropped in quotation box in the office of the Sub divisional Engineer, Indravathi Sub- Division, Central Water Commission, Kumharpara, Jagdarpur-494001. The sealed envelop should be super scribed "Replacing of AC sheets to Site office situated at Murthahandi.
2. EMD of Rs.1300/- is to be furnished along with the quotations. The EMD of unsuccessful bidders will be returned as soon as the work awarded to the successful bidder.
3. In the event of opening of quotation being a holiday will be opened on the next working day with timings unchanged.
4. Quotationers must have PAN number and the copy of the same is to be submitted.
5. The undersigned does not bind him self to accept the lowest quotation and reserve the right to accept or reject any or all the quotations without assigning any reason thereof.
6. No tools and plants shall be issued to the contractor.
7. Before starting the work, material/colours of paints and distemper shall be got approved from SDE.

8. The time of completion shall be strictly adhered.
9. In case the work is not commenced within 7 days from receipt of work order, the EMD will be forfeited to the President, Govt. of India and the contract will be cancelled.
10. The date of start shall be reckoned from the day of date of issue of work order.
11. All materials required for the work are to be supplied by the contractor. The material must be standard quality and as per specifications and free from all defects. material if found defective subsequently or not conforming to the specifications as stated above, have to be replaced by the firm without any additional charges. The work shall have a warranty period of minimum six months from the date of completion.
12. The quantity of work may be increased or decreased at the time of order without assigning any reason thereof.
13. The rate quoted should be inclusive of all duties, taxes and other levies as applicable. No other incidental charge, whatsoever will be entertained.
14. The validity of quotation for acceptance shall be 60 days and rates quoted should remain valid for 90 days from the date of opening.
15. The rate should be quoted both in words and in figures. Correction/overwriting in the quotation if any shall be made by initialing, dating and re-writing.
16. The payment will be made by DD or Account Payee cheque drawn on SBI ,Red hills Branch, Hyderabad on production of pre-receipted bill in triplicate only after satisfactory completion of the work as per specifications.
17. TDS shall be deducted from the bill at time of payment as per latest Govt. orders.
18. The security Deposit @ 10% of bill amount will be deducted from the bill and will be released after 6 months from the date of completion of work and on satisfaction of the work done.
