The received quotations will be opened by the Executive Engineer, LKD, CWC, Hyderabad on the same day at 1530 hrs in the presence of quotationers or their representatives if present.
2. The cover containing the quotations should be superscribed with **quotation for the "Work of Transportaion of 18' FRP Boat excluding Loading and Unloading"** due for opening on 31.08.2012 at 1530 hrs.
3. The rates quoted should be net inclusive of all taxes and no other charges payable extra.
4. The Corrections & over writings should be initialed by the quotationers, otherwise the quotation will be dis-qualified.
5. The rates and amount for each item should be quoted in figures as well as in words, in case of any discrepancies the rates quoted in words will be treated as final.
6. The rates should be kept valid for a period of 60 days from the date of opening the quotation.
7. Payment will generally be released within 15 days from the date of receipt of materials in full, correct and in good condition, or Bill whichever is later
8. The Executive Engineer reserves the right to accept or reject any quotation in full or partly without assigning any reason.
9. Complete responsibility lies on the transportation Agency to reach the materials in good condition.
10. Taxes as applicable will be deducted at source from the bill.
