NOTICE INVITING QUOTATIONS

For and behalf of the President of India, sealed quotations are invited from Government contractors, for Painting of office building at Site-2A, Kurundwad as per the specifications, drawings and terms and conditions enclosed.

The schedule duly filled in giving the rate and amount for each item and signed by the contractor should be enclosed along with the quotation. EMD in the form of demand draft drawn in favour of the Executive Engineer, Upper Krishna Division, CWC, on any nationalized bank payable at Pune should be enclosed along with the quotation. Quotation without EMD will be rejected.

TERMS AND CONDITIONS


1. Each bidder shall submit only one quotation. Normally, the lowest rates quoted will be accepted.
2. Only those firms who are using good quality of materials as stipulated in the Indian standards and who will be able to execute the work within the stipulated period need to quote the rates.
3. The agency should have valid registration from competent government department for execution of this type of work. A copy of license to this effect need to be enclosed with the quotation.
4. All the eraser mistakes, over writings should be duly attested.
5. Performance security deposit of 10% of the quoted cost will be retained at the time of payment and the same will be released after six months or full monsoon whichever is later after checking the worthiness, trouble free performance of water proofing treatment of the existing terrace and stability at different working conditions.
6. Payment will be generally be made crossed cheque/Demand draft on State Bank of India within twenty days from the date of completion of full work in all respects or on receipts of the bill whichever is later.
7. The material shall be accepted only after due inspection by the office of CWC during construction and before finishing. Usage of any substandard material if noticed will make the work liable to be rejected by CWC; schedule of work program shall be intimated for arranging inspection.
8. The time allowed for carrying out the work will be 15 days from the day after the date of written order to commence the work or from the first date of handling over of the site whichever is later.

9. Quotation placed in a sealed envelope, with the name of the work and due date written on the envelope will be received by the **SUB-DIVISIONAL ENGINEER, UPPER KRISHNA SUB-DIVISION-II, CWC, MIRAJ** up to **15:00hrs on 08/12/2014** and will be opened by him or his authorized representative in his office on the same day at **15:30 hrs**.
10. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without assigning any reason. And also reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
11. All quotations in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
12. The quotation for the work shall remain for acceptance for a period of 90 days from the date of opening of quotation. If any tenderer withdraws his quotation, then the government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
13. All the debris and un-used materials etc. should be removed from the work site as soon as the work is completed. No extra charges will be paid for this purpose.
14. After satisfactory completion of the works in all respects, the bill in triplicate may be submitted for payment to the undersigned.

15. Dispute settlement


If over the works any dispute arises between the two parties, relating to any aspects of this agreement, the parties shall first attempt to settle the dispute through mutual and amicable consultation. In the event of agreement not being reached, the matter will be referred for arbitration by a sole arbitrator not below the level of retired Superintending engineer, CPWD to be appointed by the first party. The arbitration shall be conducted in accordance with the arbitration and conciliation Act, 1996. The decision of the Arbitrator shall be final and binding on both the parties.
